On 20 December 2023 Ofgem published its consent, in accordance with Standard Condition 38C of the Electricity Distribution Licence and Amended Standard Condition BA5 of the Independent Distribution Network Operator's (IDNOs) Licence, to Leep Electricity Networks Ltd making a Valid Bad Debt Claim from Distribution Network Operators (DNOs) of up to £276.03.
